
Sir,

It has been observed that your sugar mill has not furnished the Annual Return in Statement-I to IV for the sugar season 2014-15 containing the details of sugarcane crushed, sugar produced and sugar recovery % cane etc. to this Directorate in reference to the letter of even number dated 31st August, 2015 so far. The submission of said return is very important as the information furnished therein is to be used for calculation/fixation of Fair and Remunerative Price (FRP) of sugarcane payable to the farmers by the sugar mills during current sugar season 2015-16, besides other statistical uses.

2. Annual Return in the prescribed format Statement-I to IV is a statutory return called for under the provisions in Clause 10 of the Sugar Control (Order), 1966 which has been issued in exercise of the powers conferred by the Section 3 of the Essential Commodities Act, 1955. Its timely non-submission is violation of the provisions of the Essential Commodities Act, 1955 and punishable under Section 7 of the said Act.

3. You are, therefore, directed to submit the above return of the last sugar season 2014-15 urgently to this Directorate latest by 25th June, 2016.


